A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on the 17th, day of June, 2013 commencing at 9:00 o'clock a.m. Present were Chair Scott McDonald, Commissioners Ronald Wertz and Paul Nichols and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News. Board agendas are posted on the County's website <u>www.hitchcockcounty.ne.gov</u>.

Notice of the meeting and availability of the agenda were given to the Chair and all members of the Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. Emergency Manger Patrick Gerdes met with the board and advised as to the 2013/2014 Emergency Management Budget. Discussion held on Code Red Notification System and various budgetary items of interest.


Discussion was held on bids received at the June 3rd, 2013 meeting and the same were reviewed.

Member Wertz moved to purchase the 2001 Freightliner S/N 1FUYSSEB71LG56971, C120 Day Cab from Nebraska Truck Center in the amount of \$23,750.00. Member McDonald seconded the motion and after consideration the following members voted in favor of said motion: McDonald, Wertz and Nichols. Motion carried.

Attorney Garner joined the meeting and advised as to the ADA Policy for the Nebraska Department of Roads. Mr. Garner presented a proposed preliminary self evaluation and transition plan and an ADA policy on the Department of Roads form.

Member Wertz moved to adopt the Preliminary Self-Evaluation and Transition Plan. Member Nichols seconded the motion and after consideration the following members voted in favor of said motion: McDonald, Nichols, and Wertz. Motion carried. Chair McDonald executed said plan.

Member Nichols moved to adopt a policy pertaining to Section 504 – Rehabilitation Act of 1973, Americans with Disabilities Act of 1990. Member McDonald seconded the motion and after consideration, the following members voted in favor of said motion: Wertz, Nichols and McDonald. Motion carried. Said policy executed by all members of the board.



Barry Corder joined the meeting and discussion was held on 2013/2014 salary and the Veteran's Service Office budget. Mr. Corder advised as to the Hitchcock County Veteran's Service Committee Members.

Member McDonald moved to approve the Hitchcock County Veteran's Service Committee Members as follows: Thomas Jones, Wilbert Wagner, Robert Brown, Fred Weber and Richard Baxter. Member Wertz seconded the motion and after consideration the following members voted in favor of said motion: Nichols, Wertz and McDonald. Motion carried.

Clint Johnston with Southwest Title Company joined the meeting and the settlement statement on Lots 1 & 2, Block 8, King's 1st Addition to Culbertson was reviewed.

Chair McDonald executed the settlement statement and related documents on Lots One (1) and Two (2), Block Eight (8), King's First Addition to Culbertson, Hitchcock County, Nebraska by and between Hitchcock County and Carrol S. Clapp.

Member Nichols moved to deliver a cashiers' check in the amount \$7,649.80 to Southwest Title Company as escrow agent pursuant to settlement statement relating to Lots 1 and 2, Block 8, King's First Addition to be held until delivery of the executed warranty deed. Member Wertz seconded the motion and after consideration the following members voted in favor of said motion. Wertz, Nichols, and McDonald. Motion carried.

Member McDonald moved to recess the meeting at 12:06 p.m. to enter into Board of Equalization proceedings this date. Member Nichols seconded the motion and the following member of the board voted in favor of said motion: Wertz, McDonald, and Nichols. Motion carried.

Chair reconvened the regular meeting at 12:18 p.m. this date.

Discussion was held regarding 2013/2014 salaries for deputies and others.

Member McDonald moved to set chief deputy salaries for fiscal year 2013/2014 beginning July 1, 2013 as follows: Chief Deputy Clerk \$32,627.00, Chief Deputy Treasurer \$32,304.00 and Chief Deputy Sheriff \$39,289.28. Member Wertz seconded the motion and after consideration, the following members voted in favor of said motion: Wertz, McDonald, and Nichols. Motion carried.

Member Wertz moved to allow employee compensation as set out in the 2013/2014 compensation schedule to become effective July 1, 2013. The motion was seconded by McDonald and after consideration, the following members voted in favor of said motion: Wertz, McDonald and Nichols. Motion carried. The compensation schedule is available for inspection in the office of the County Clerk.

The Treasurer was in receipt of \$30.00 from NACO for registration refund and \$79.95 from Hayes County for lodging reimbursement, both credited to the General Fund.

Member McDonald moved to adjourn and to meet for the next regular meeting on Monday, July 1^{st,} 2013 at 9:00 a.m. Member Nichols seconded the motion and the roll was called with the following members voting in favor of said motion: Wertz, Nichols, and McDonald. Motion carried.
