A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday, the 7<sup>th</sup>, day of August, 2017. Chair called the meeting to order at 9:00 a.m. Present were Chair Scott McDonald, Commissioners Ron Wertz and Paul Nichols and County Clerk Margaret Pollmann. Member Wertz moved to approve the following members on the Hitchcock County Veteran's Service Committee effective 7-1-17: Thomas Jones, Wilbert Wagner, Robert Brown, Dennis Kennedy, and Richard Baxter. Member McDonald seconded the motion and after consideration, the following members voted in favor of the motion: Nichols, Wertz and McDonald. Motion carried.

The Treasurer was in receipt of \$77.23 from Central Crude for oil production and \$75.00 from NACT for refund on overpayment of dues, both credited to the General Fund; \$1.00 from Vonage America and \$6.00 from Quest Corp. for 911 surcharges, both credited to the 911 Emergency Service Fund.

Attorney Garner advised as to the delay rental check from Manual Corporation.

Chair McDonald acknowledged a check in the amount of \$7.10 for a delay rental from Manual Corporation.
