A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday, the 18th, day of December, 2017. Chair called the meeting to order at 9:00 a.m. Present were Chair Scott McDonald, Commissioners Ron Wertz and Paul Nichols and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. Discussion held on health insurance.

Member Wertz moved to recess at 10:55 a.m. The motion was seconded Nichols and the following members voted in favor of the motion: Wertz, Nichols and McDonald. Motion carried.

The meeting was reconvened at 12:55 p.m. in the Community Room, Hitchcock County Courthouse. In accordance with NEB. REV. STAT. §23-107.01, a public sale of eight (8) tracts of County owned property commenced at 1:00 p.m. Attorney Garner gave opening statements and advised as to pertinent statutes. County Clerk Pollmann read the legal description for each of the eight (8) tracts and stated the fair market value for each tract as set by the Board on November 6th, 2017. The sale and bidding commenced as per stated procedures.

The public sale concluded at 1:37 p.m.

Member Wertz moved to accept the bid of Randy J. Brown on Tract #1 described as Lots 5 & 6, Block 5, Original Town of Trenton, Hitchcock County, Nebraska in the amount of \$700.00. Member Nichols seconded the motion and after consideration, the following members voted in favor of the motion: McDonald, Wertz and Nichols. Motion carried.

Member Nichols moved to accept the bid of Mark Brown on Tract #2 described as a strip of land 4 rods wide, commencing at a point on the east section line of Section 28, T1N, R32W, Hitchcock County, Nebraska, approximately 8 rods North of the SE Corner of the NE¼ of said Section 28, running thence in a southwesterly direction circling around bend in South Driftwood Creek to a point approximately 47 rods south of said SE corner of the NE¼ of said Section 28, containing 2.5 acres, more or less, in the amount of \$500.00. Member Wertz seconded the motion and after consideration, the following members voted in favor of the motion: Nichols, Wertz and McDonald. Motion carried.

Member Wertz moved to accept the bid of Phyllis Berndt on Tract #3 described as a strip of land lying over and across the SE½ of Section 28, T2N, R33W, Hitchcock County, Nebraska, described as follows: Beginning at the SE corner of said Section 28; thence northerly on the East line of said Section 28, a distance of 2652.1 feet to the NE corner of the SE¼ of said Section 28; thence westerly on the North line of said SE¼, a distance of 46.1 feet; thence southerly 845.6 feet to a point, (said point being 45.4 feet westerly from said East line); thence continuing southerly 0°13' left, a distance of 1806.5 feet, to a point on the South line of said Section 28; thence easterly, on said South line, 37.0 feet to the point of beginning, containing 2.596 acres, more or less, subject to 2.009 acres, more or less, of existing occupied County Road Right-of-Way, in the of \$100.00. Member Nichols seconded the motion and after consideration, the following members voted in favor of the motion: Wertz, McDonald and Nichols. Motion carried.

Member Nichols moved to accept the bid of Phyllis Berndt on Tract #4 described as a strip of land lying over and across the NE½ of Section 28, T2N, R33W, Hitchcock County, Nebraska, described as follows: Beginning at the NE corner of said Section 28; thence southerly on the East line of said Section 28, a distance of 2664.9 feet, to the SE corner of the NE½ of said Section 28; thence westerly on the South line of said NE½, a distance of 46.1 feet; thence northerly a distance of 2664.9 feet, to a point on the North line of said Section 28, (said point being 48.5 feet westerly from said NE corner); thence easterly on said North line, 48.5 feet, to the point of beginning, containing 2.894 acres, more or less, subject to 2.019 acres, more or less, of existing occupied County Road Right-of-Way, in the amount of





\$100.00. Member McDonald seconded the motion and after consideration, the following members voted in favor of the motion: McDonald, Nichols and Wertz. Motion carried.

Member McDonald moved to find that the \$10.00 bid of Shirley McConnell on Tract #5 is not substantially less than fair market value and further, to accept said bid on Tract #5 described as a strip of land lying over and across the NW¼ of Section 27, T2N, R33W, Hitchcock County, Nebraska, described as follows: Beginning at the NW corner of said Section 27; thence southerly on the West line of said Section 27, a distance of 2664.9 feet, to the SW corner of the NW¼ of said Section 27; thence easterly on the South line of said NW¼, a distance of 33.9 feet; thence northerly a distance of 2664.9 feet, to a point on the North line of said Section 27, (said point being 31.5 feet easterly from said NW corner); thence westerly on said North line, 31.5 feet to the point of beginning, containing 2.000 acres, more or less, subject to 1.990 acres, more or less, of existing occupied County Road Right-of-Way. Member Wertz seconded the motion and after consideration, the following members voted in favor of said motion: Nichols, McDonald and Wertz. Motion carried.

Member McDonald moved to find that the \$250.00 bid of GM Sutton on Tract #7 is not substantially less than fair market value and further, to accept said bid on Tract #7 described as 13.32 acres of land located in the NE¼NE¼ and N½SE¼ of Section 4, T1N, R34W, Hitchcock County, Nebraska as more particularly described in Surveyors Record Book #3, Page 46, in the Hitchcock County Register of Deeds Office, subject to existing occupied County Road Right-of-Way. Member Nichols seconded the motion and after consideration, the following members voted in favor of said motion: Wertz, Nichols and McDonald. Motion carried.

Member Wertz moved to accept the bid of BDL Farms on Tract #8 described as 3.13 acres located in the E½SE¼SE¼ of Section 33, T2N, R34W, Hitchcock County, Nebraska as more particularly described in Surveyors Record Book #3, Page 46, in the Hitchcock County Register of Deeds Office, subject to existing occupied County Road Right-of-Way. Member Nichols seconded the motion and after consideration, the following members voted in favor of the motion: McDonald, Wertz and Nichols. Motion carried.

Board noted that no bids were received on Tract #6 described as a strip of land lying over and across the SW¼ of Section 27, T2N, R33W, Hitchcock County, Nebraska, described as follows: Beginning at the SW corner of said Section 27; thence northerly on the West line of said Section 27, a distance of 2652.1 feet, to the NW corner of the SW¼ of said Section 27; thence easterly on the North line of said SW¼, a distance of 33.9 feet; thence southerly a distance of 845.6 feet to a point, (said point being 34.6 feet easterly from said West line); thence continuing southerly 0°13' left, a distance of 1806.5 feet to a point on the South line of said Section 27; thence westerly on said South line 43.0 feet to the point of beginning, containing 2.273 acres, more or less, subject to 2.009 acres, more or less, of existing occupied County Road Right-of-Way.

The Treasurer was in receipt of \$36.40 from Mid American Benefits for a refund, credited to the General Fund.

Member McDonald moved to adjourn at 1:57 p.m. and to meet for the next regular meeting on Tuesday, January 2nd, at 9:00 a.m. Member Nichols seconded the motion and the roll was called with the following members voting in favor of said motion: Wertz, McDonald, and Nichols. Motion carried.
