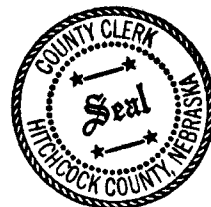
NON INCUMBENTS (new filers)

All judges who file for retention with the Secretary of State by August 1, 2024 will appear on the General Election ballot in their respective districts and counties.
